 Bartel Bergmann is listed in Tiegenhagen, Royal Prussia, Poland, in the 1727 census, but it is not certain whether this refers to # 398 or his father (not very likely to have been anyone else, considering that Bartel was a relatively rare first name); no Bargmanns are listed there in the 1764 or 1776 censuses
