

Only four Pötger families moved to Ukraine, all from the Kulm area in 1821-23, according to Unruh, with their residence in 1835 revision added:

(1) Jakob Pätkau (Petker), farmer from Schöneich, m. to Elisabeth Brandt, and son Jakob, to Tiegerweide in 1821; b. ca. 1785 (son of Gerhard), lived in Tiegerweide # 15 in 1835, together with 2nd wife Katerina, b. ca. 1794, and 4 daughters aged 5-14

(2) Heinrich Poetker, married, from Jamerau to Molotschna in 1822; he was the son of Gerhard and d. in Liebenau # 7 in 1834, but his widow, Maria, b. ca. 1794, was still alive in 1835 and lived there with 4 children, ages 5-18

(3) Heinrich Poetker, farmer, b. 1787, m. to widowed Gaede, with stepchildren Peter and Maria Gaede, from Klein Lunau to Molotschna in 1823; he lived in Friedensdorf # 26 in 1835 and was a widower

(4) Johann Poetker, farmer, b. 1787, m. to Maria Nickel, with children Heinrich (8), Johann (7), Agnes ($\frac{1}{2}$), from Klein Lunau to Molotschna in 1823; he lived with 2nd wife in Friedensdorf # 5 in 1835

Endnote 192: The Katie Peters Card File Index at the Center for Mennonite Brethren Studies Archives in Winnipeg includes the following data on Berend Brandt, who was the oldest brother of the Peter Brandt who emigrated to Molotschna and of Johann Brandt, who settled in Burwalde, Chortitza, in 1804, and who may very well be the ancestor of the Brandt families of Chortitza origin who settled in Canada (and possibly in the United States):

Berend Brandt, b. 25 July 1775, d. 30 May 1848, m. Elisabeth Thiessen, b. 24 Mar. 1785, d. 4 Oct. 1823. Their children included:

- (1) Elisabeth, b. 2 June 1808, d. 28 Aug. 1881
- (2) Helena, b. 10 Dec. 1818 in Altmünsterberg, West Prussia, d. 1847, m. Abraham Hiebert
- (3) Catharina, b. 3 Mar. 1822
- (4) Maria, b. 6 Sept. 1823 in Altmünsterberg, West Prussia, d. 9 Dec. 1886, m. Martin Thiessen, b. 4 Mar. 1825, d. 9 Dec. 1886

Endnote 197: If the year of birth of Susanna Dyck Reimer (ca. 1763) is even approximately correct and she was still alive at the time of the 1835 revision, she must have been married at least a fourth time., viz., to one of the following listed in 1835:

- (1) Herman Neufeld (son of Peter), age 74 (whose wife Susanna was 71 and therefore b. ca. 1763), Münsterberg 27 (at least his second wife)
- (2) Peter Wiens (son of Peter), age 65 (whose wife Susanna was 71 and therefore b. ca. 1763), Rückenau 26 (his 3rd wife, with his youngest living son, who was still at home, having been born ca. 1811)
