Stobbendorf, which is inconsistent with the reference to coming from Zeyersniederkampen in the 1803 emigration list. Moreover, he is shown in the latter as having 3 sons and 2 daughters (2 sons and 1 daughter by his second wife), and both children by his first wife were married and living in Molotschna in 1808. Therefore, I seriously doubt that the very brief Chortitza entry is relevant.

Endnote 444: There is some confusion in the records concerning Peter Dück's three marriages, but I think that his second marriage was to Maria Friesen in 1803-04 and that she died in 1805-06.

According to files of Mennonite Genealogy, Inc., Peter Dück was the son of Philipp or Filip Dück, which has now been confirmed by the 1835 revision. There were several Philip Dücks, but I believe that this family came from Einlage an der Nogat, Amt Elbing, in the Rosenort church district.

There were 8 Peter Dycks, 2 Peter Dücks and 1 Peter Dick listed in the land census of 1789.

Endnote 801: Goertz's list of marriages in Thiensdorf-Markushoff, 1776-1800 (MHC copy of typescript) shows two marriages to a Widow Unger: (1) by widower Clas Kätler on 24 July 1778 and (2) by Cornelius Harms of Aschbuden on 23 June 1785. The information is sparse, but it is quite likely that these may have been the second and third marriages of Mrs. Adrian Unger. The Orlofferfelde records include some entries for Thiensdorf, which also was a Frisian congregation. Augustwalde would have been in the area covered by that congregation. Presumably the Unger children were baptized in Orlofferfelde because the family had lived there previously, probably until a late date.

Endnote 802: There were numerous Jantzens in the Orlofferfelde church records. Heinrich may have been the son or grandson of Peter, Jacob, Heinrich or Frantz, listed in the 1727 census. A Heinrich Jantzen, son of Peter, was baptized in Orlofferfelde in May 1757. He appears to be the most likely father, on the basis of age, among the several possibilities.

Endnote 809: All of the children of Stammvater Peter Heidebrecht were born to his first wife, according to Hermann Thiessen, Peter Heydebrecht und seine Nachkommen.

Endnote 826: Jacob Regehr is listed at Ladekopp in 1778, Ladekopperfeld in 1779 and 1781, and in Ladekopp again in 1782 and 1786. Jacob Reger of Ladekopp is mentioned in 1789.

Catarina, the wife of Jacob Reger, Ladekopp, died on 29 April 1798 at the age of 47 (thus born ca. 1751) and Jacob Reger of Ladekopp died on 18 May 1801 at the age of 66 (thus born ca. 1735). All of these entries are in the Ladekopp church records and it seems clear to me that they all refer to the same family.

I originally read the record as referring to Ladeigs; there is no such place. However, in August 1998 I saw a record where the entry resembled "Ladeigs," but where my deciphering skills
